Dear Owner,

The licensing office is not accepting applications in person. At this time applications must be submitted via mail, fax, courier or electronically. Payment must accompany the applications. Payment is accepted via credit/debit card or check in US funds made payable to the Minnesota Racing Commission. A credit card authorization form is available at <https://www.mrc.state.mn.us/licensing/>

Badges are NOT being issued at this time for owners.

Every individual owner and ownership entity must be licensed prior to racing in Minnesota. New in Minnesota this year are the addition of a 3-year owner's license and a 3-year ownership entity license. Fingerprints are required of all applicants ages 18 through 70 every 60 months. This year we will accept a fingerprint affidavit if fingerprints have been submitted in another jurisdiction.

Applications and fingerprint cards may be obtained by contacting the licensing office at 952-496-7950 ext. 1 or online at <https://www.mrc.state.mn.us/licensing/>. Applications that are incomplete in content will not be processed.

In addition to the Individual License Application, if the ownership entity is a corporation, LLC, joint venture, partnership, trust or estate, the Ownership Entity Application must be submitted.

If the ownership entity are spouses racing under a name other than their own, but is NOT a corporation, LLC, trust or estate, the Application for Registration of Stable Name must be submitted.

Authorized Agent	\$5.00
